Claiming Citizenship in the Shadow of the State Apr 20 2023 This thesis asks questions about the meanings and practices of citizenship, and how they change in a context of violence. Questions of citizenship are relevant because violence shifts the fundamental circumstances for citizenship. Much of the existing literature on participatory governance and democratisation assumes a certain degree of safety and security, which is a distant reality for people whose daily lives are ordered by violence and insecurity. This thesis focuses on three specific dimensions of the citizen-state relationship: a) the ways that the meanings of citizenship are formed (and the processes of socialisation that lead to a sense of citizenship); b) the ways that citizens are able to act in order to make claims on the state; the way that state and other forms of authority act in relation to citizens; and, c) the types of mediators that intervene between citizens and state institutions. The starting point for this analysis is the empirical reality of favelas in Rio de Janeiro, where power and patterns of authority operate in certain ways that are shaped by violence.

The Transformation of Citizenship, Volume 3 Oct 22 2020 This volume *Struggle, Resistance and Violence* examines the fact that all over the world the rights of citizens have come under enormous pressure and addresses the many ways in which people are 'making claims' against both autocratic and democratic authority.
